Equality data overview

This report outlines the equality data for staff and patients at The Royal Orthopaedic Hospital. The data covers the period February 1st 2019 to January 31st 2020.

As part of the Trust's Public Sector Equality Duty (PSED) equality data for staff and patients must be made available to the public via the website, following review and sign off by Trust Board members. It is therefore requested that the Staff Experience and OD committee undertake this review on behalf of the Board.

The information is split into staff data first and then patients. The sub titles link to the nine protected characteristics themes under the Equality Act 2010. These nine protected characteristics are:

- Age
- Gender
- Religious belief
- Ethnicity
- Disability
- Marital and Civil partnership
- Pregnancy and Maternity *
- Sexual orientation
- Transgender *

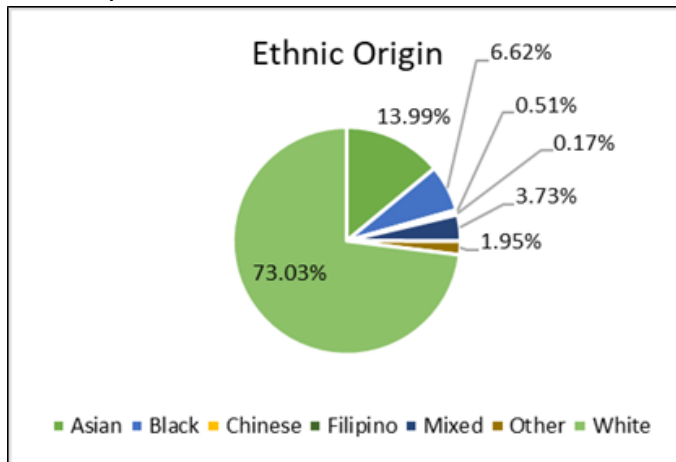
Overall the data is generally stable from the previous year. Any exceptions are noted under the particular characteristics.

This information will also be included in the annual Equality and Diversity report with further narrative linked to equality objectives and actions.

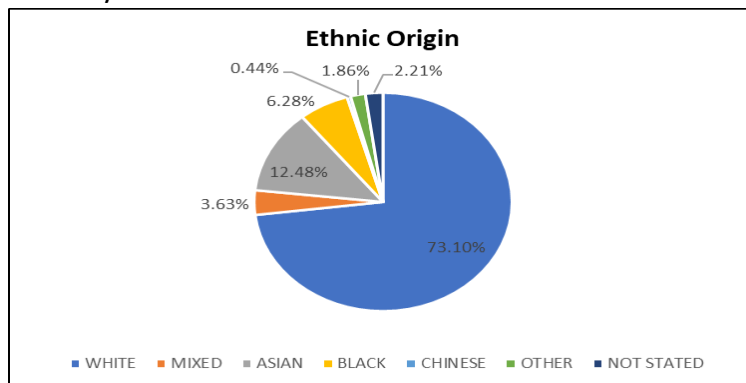
Workforce information

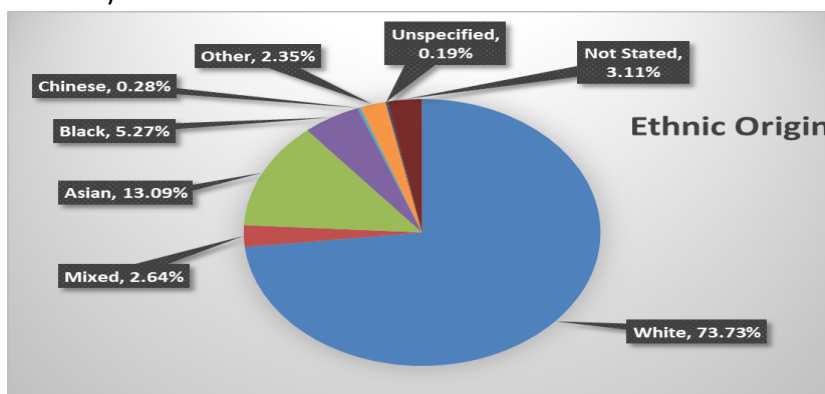
Ethnicity 2021



Ethnicity 2020

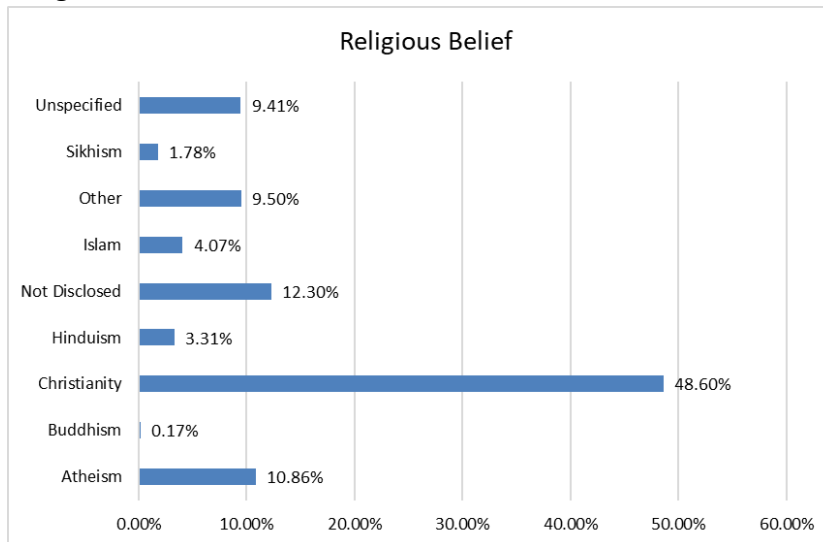

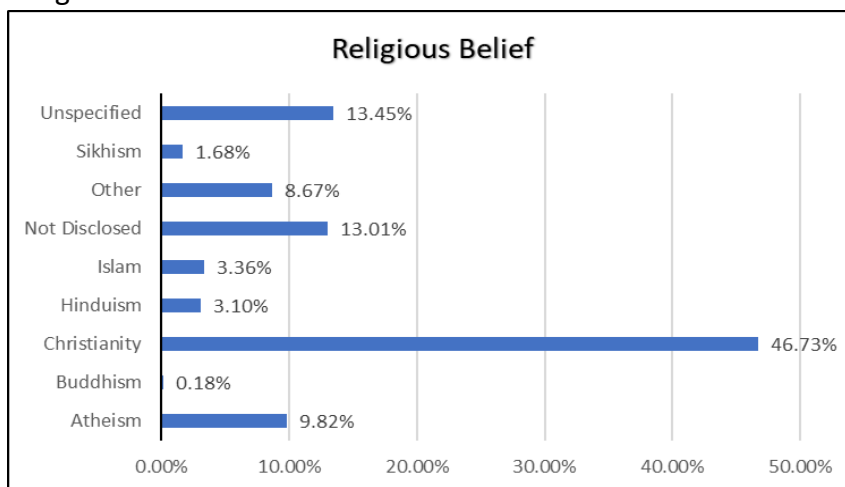


There has been no significant change in the different percentages for each of the ethnic groups with the current percentage for White at 73.10%. The census data for Northfield (2011), local to the hospital shows a marked difference for White at 82%. For the wider area of Birmingham, the census data is significantly different at 52%. This may indicate that candidates and new employees are being attracted to the Trust from outside the immediate area for advertised roles.

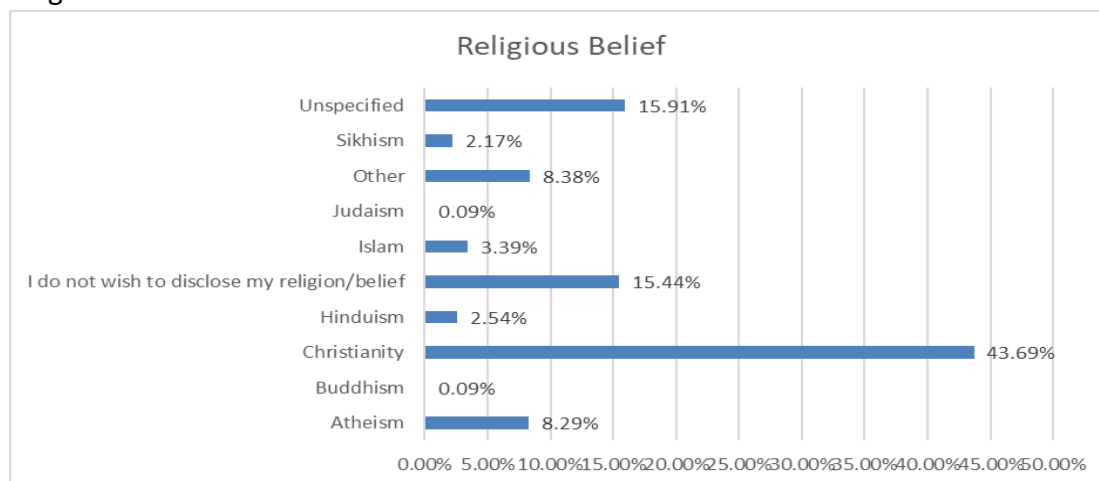
Religious Belief 2021



Religious Belief 2020

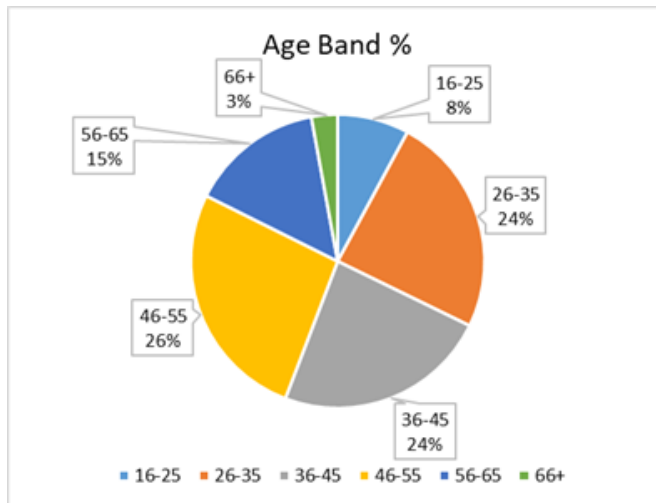

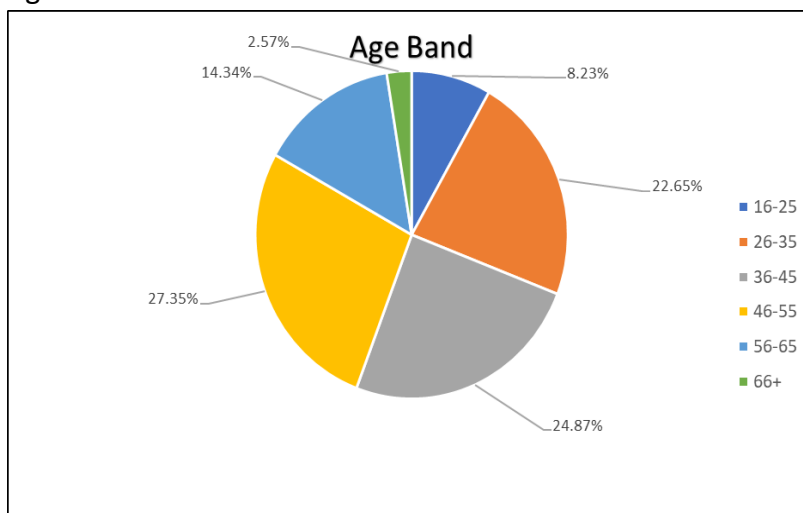


The Trust has a diverse workforce as highlighted by the data above. The Faith room at the Trust is also equipped to accommodate a range of different faiths and beliefs.

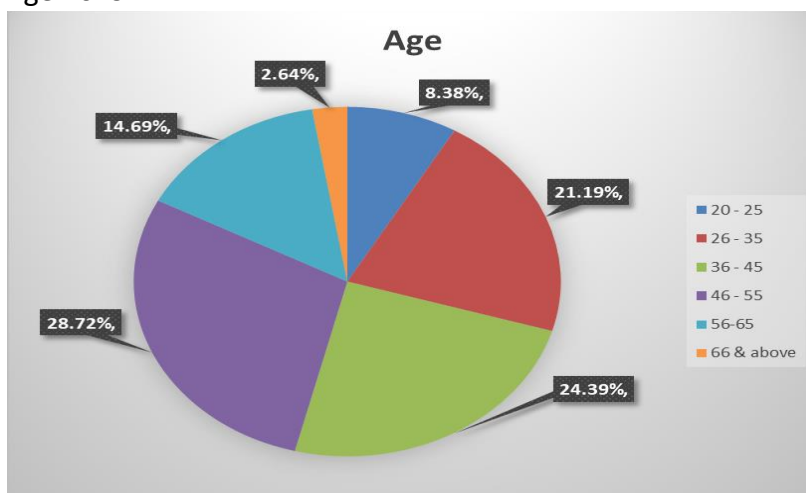
Age 2021

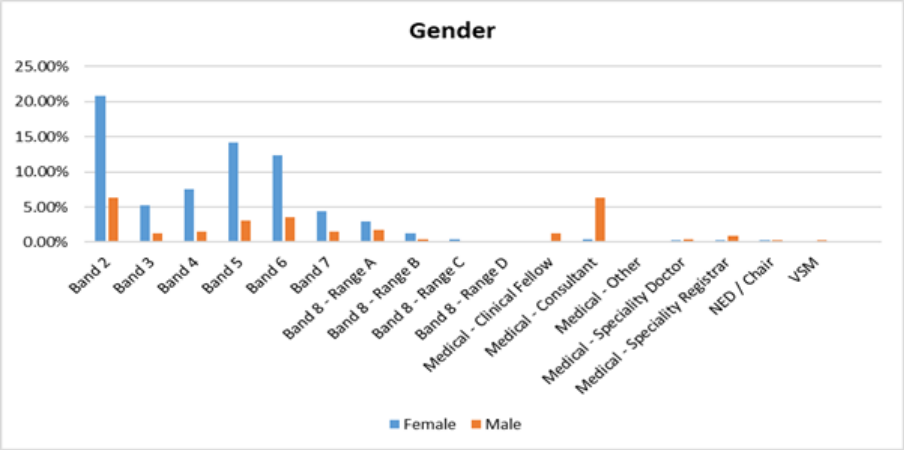

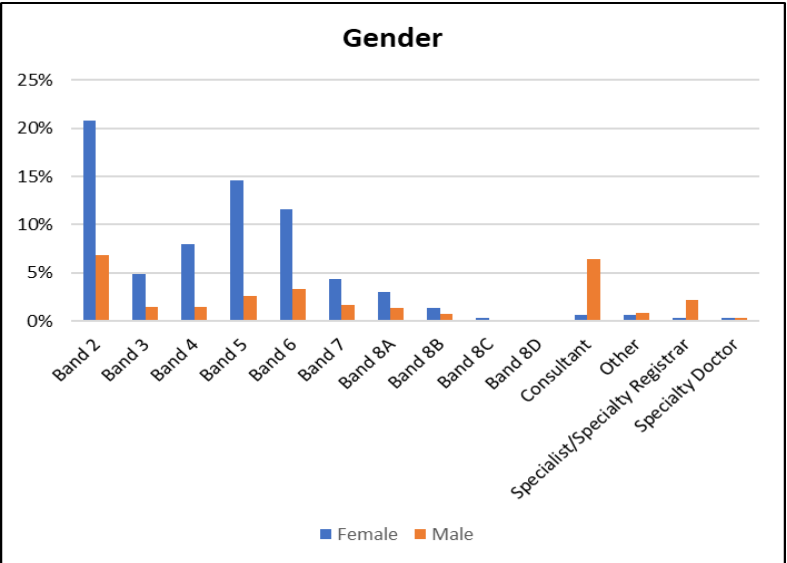

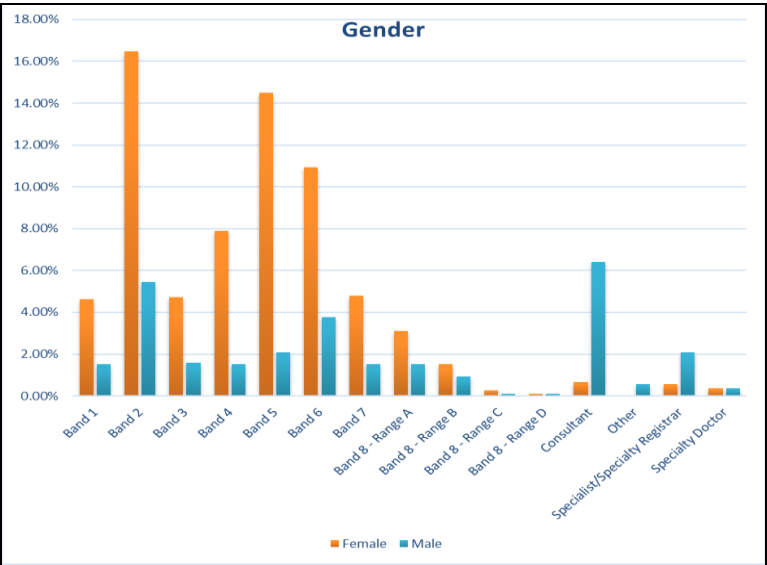
Gender 2021



Gender 2020

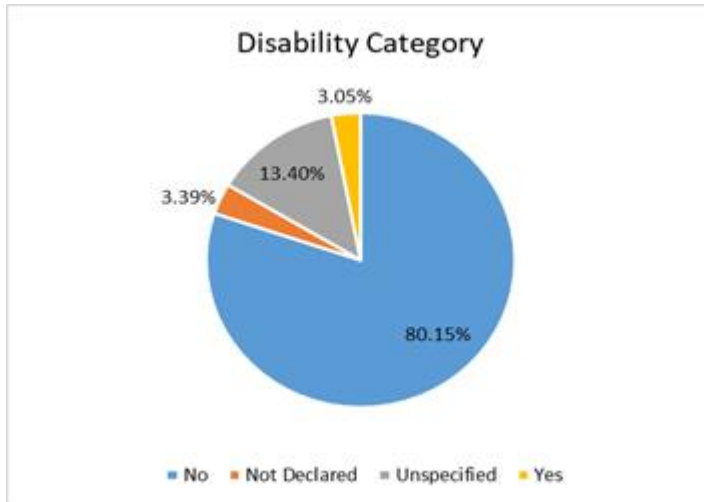

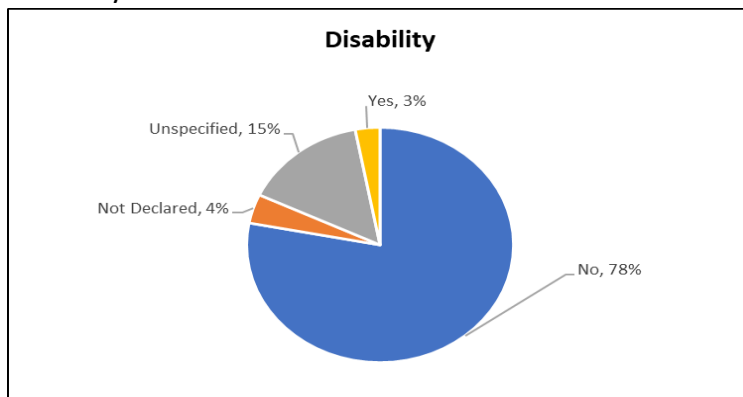


Comparing the data from 2019, it shows an increase in females at Band 2 which is mostly due to the consolidation of Band 1 and Band 2 in 2019.

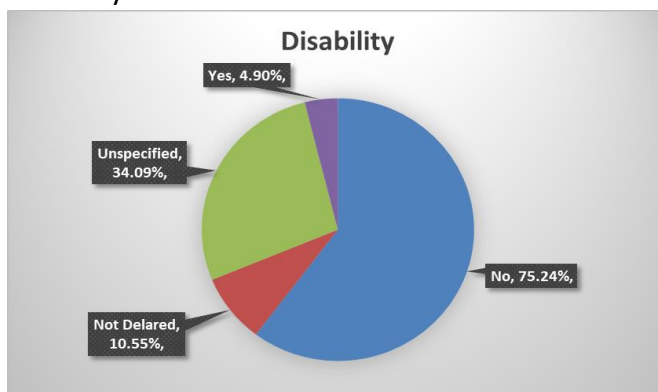

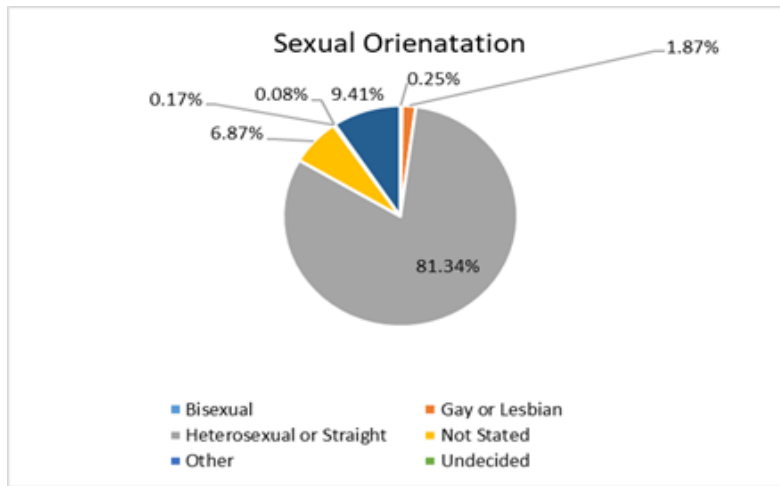

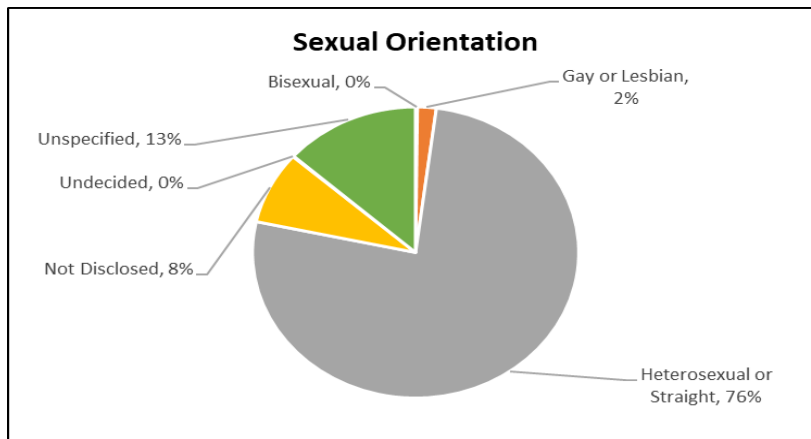

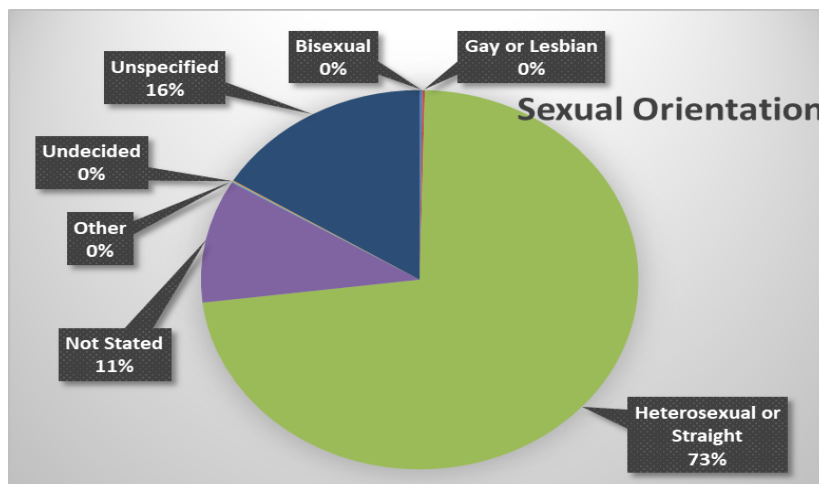

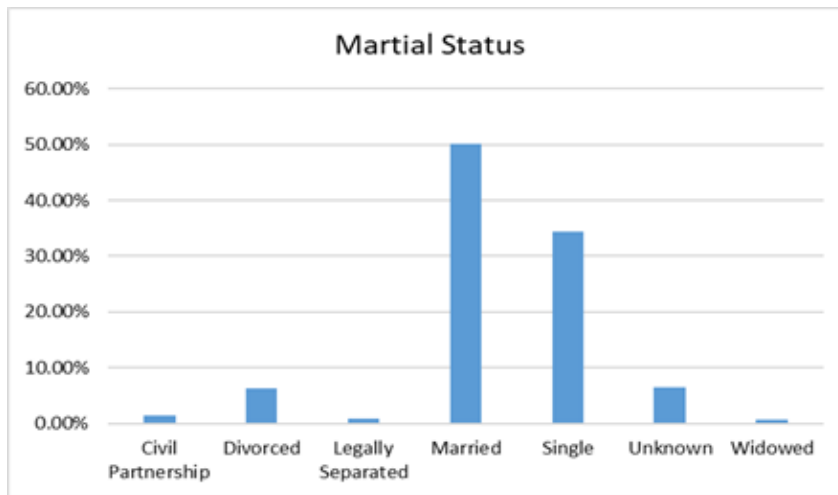

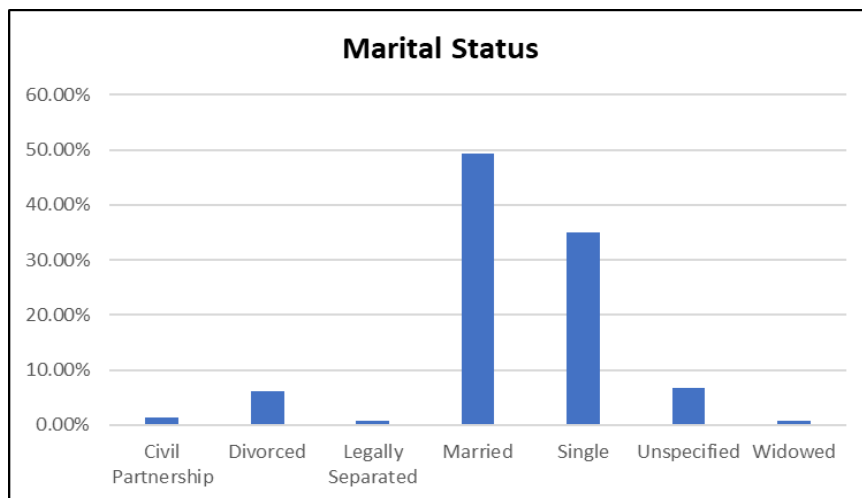

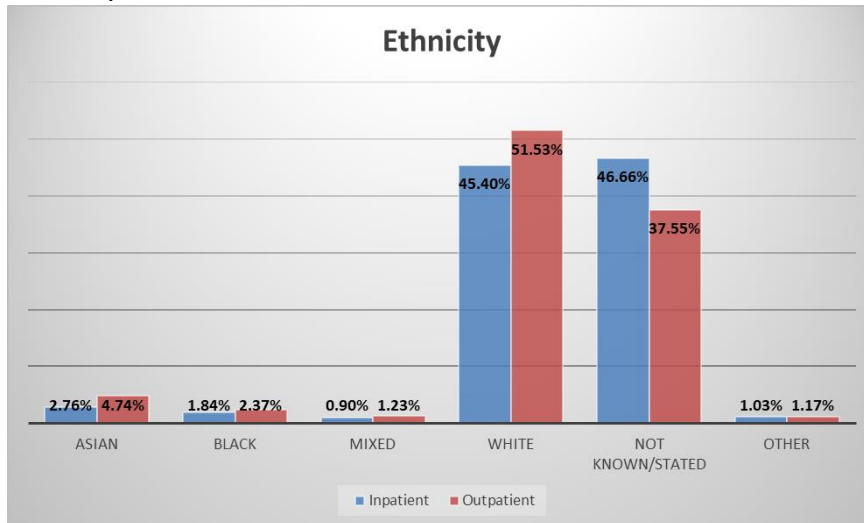


Marital Status was first reported on in 2020.

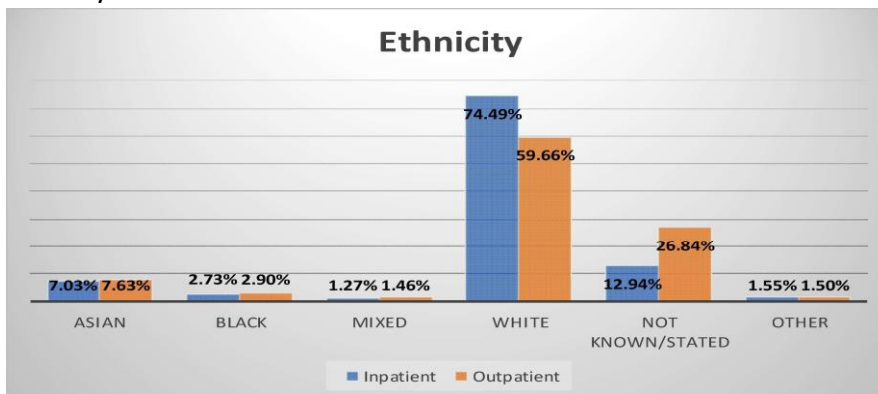
Patient data

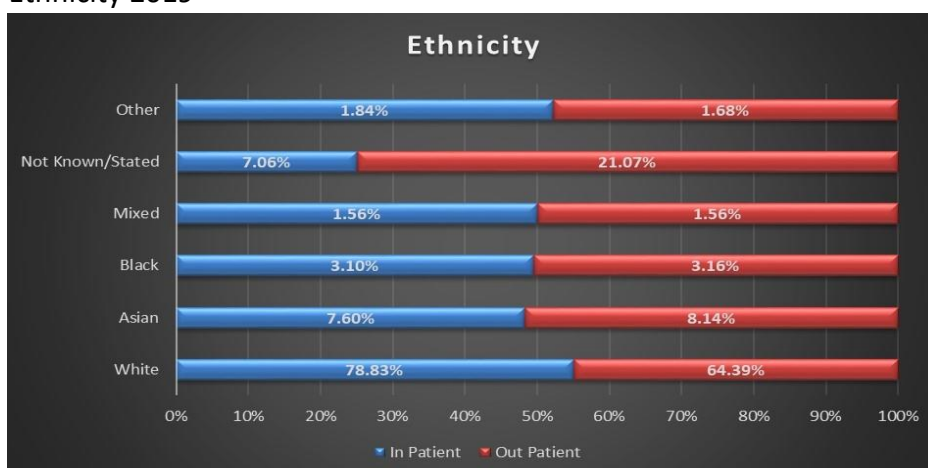

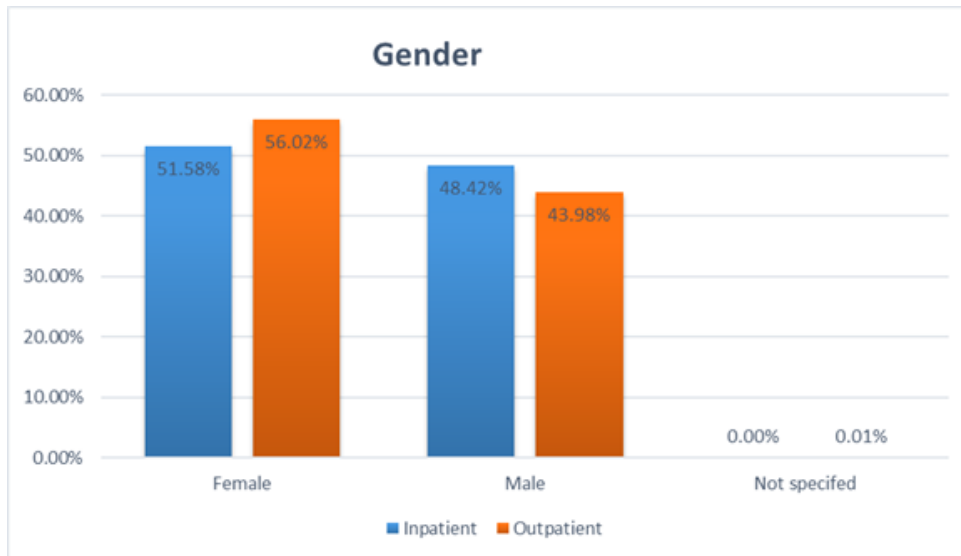

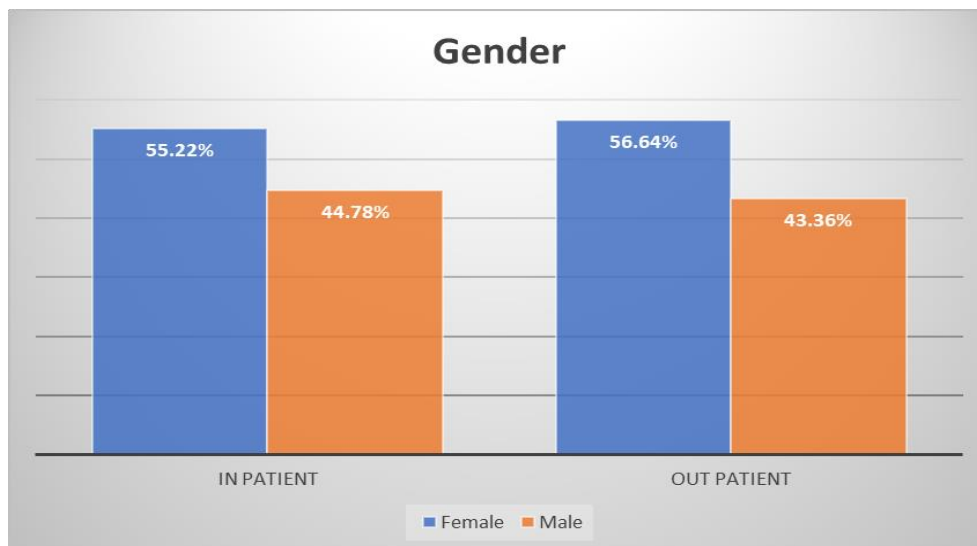


The data reflects a difference between ethnicity of staff (White 74.4%) and patient 78.83%.

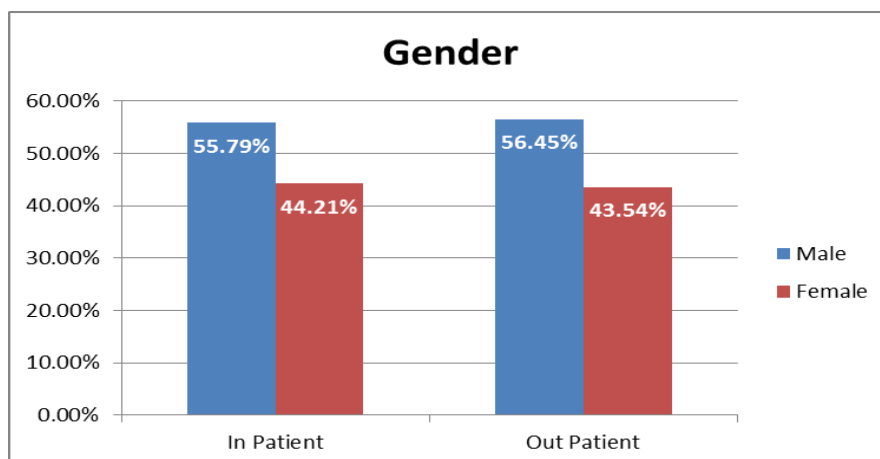
Gender 2021

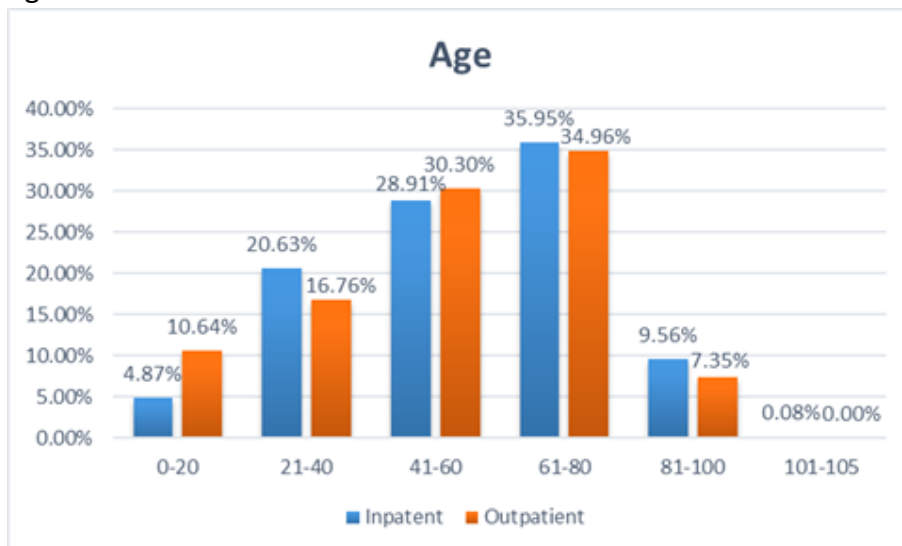

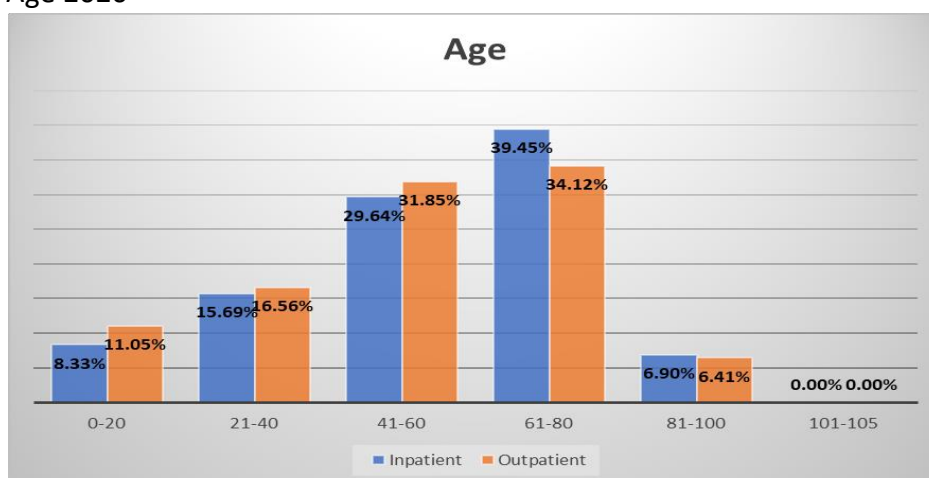


Feedback from patients does not identify any issues around Gender.

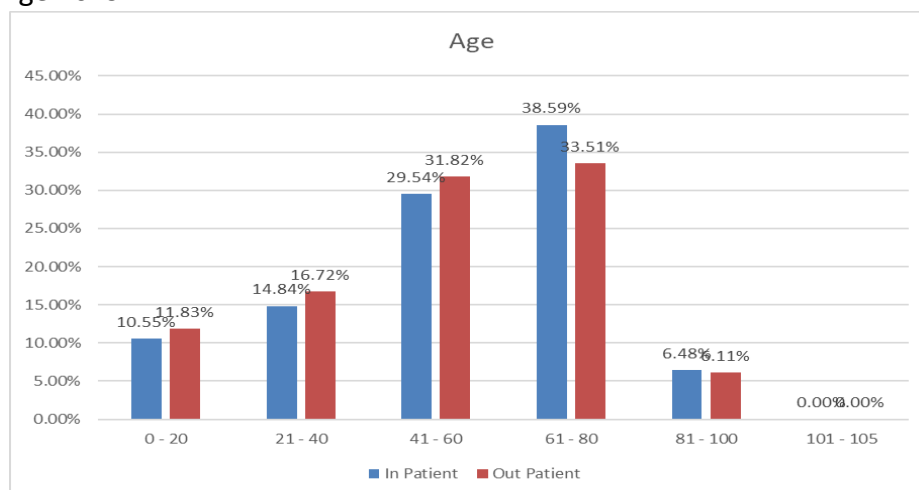

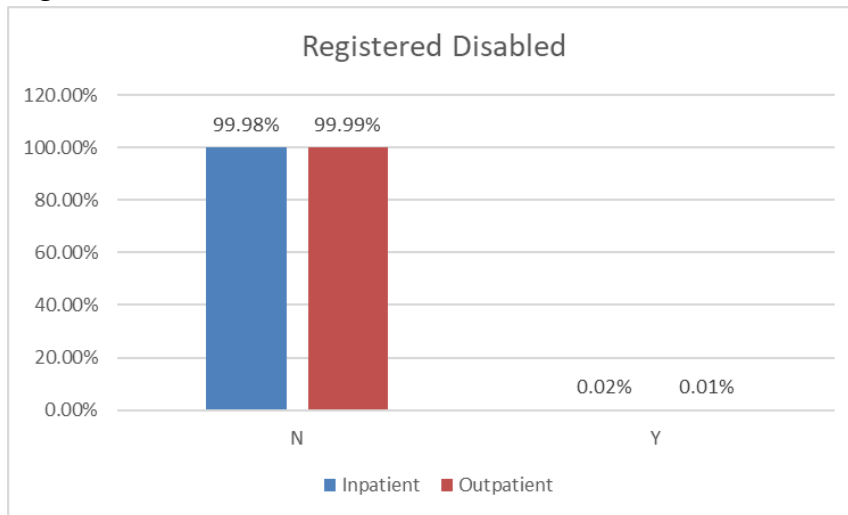

There has been an significant increase in the number of patients 'Not stating' religion. This may in part be due to the impact of GDPR.

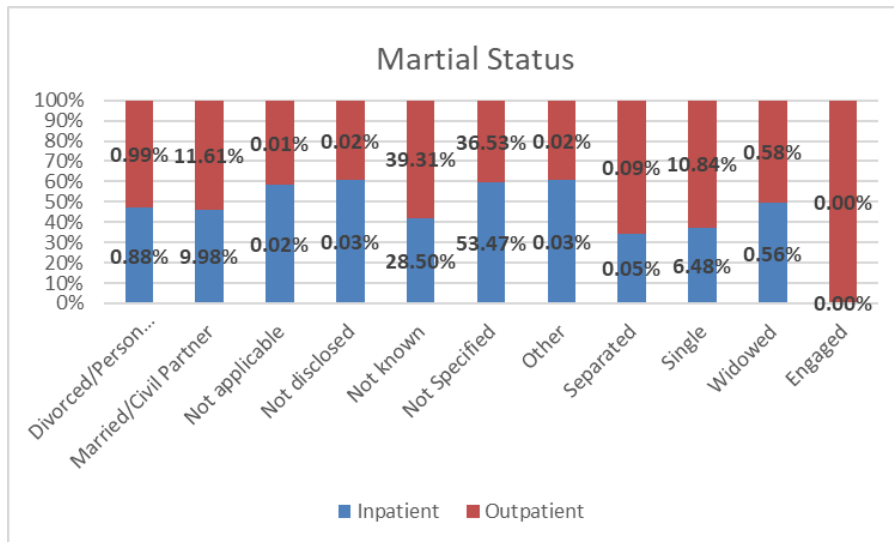
Registered Disabled 2021



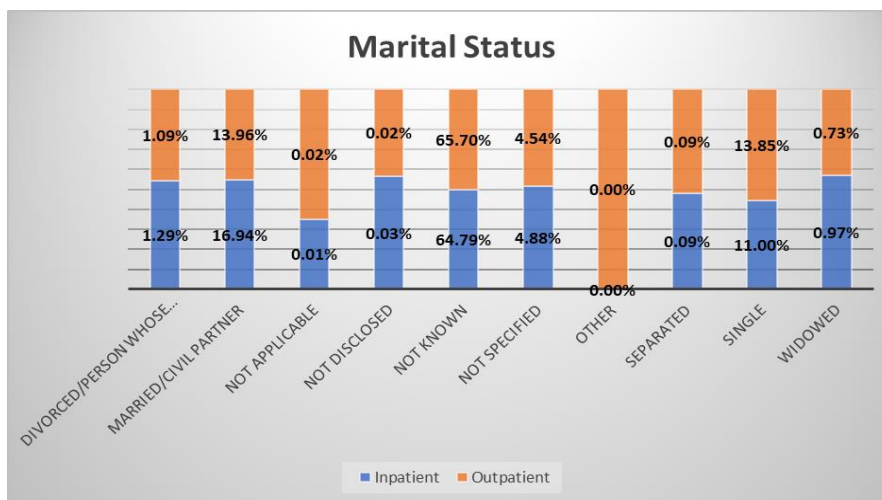
Registered Disabled 2020
